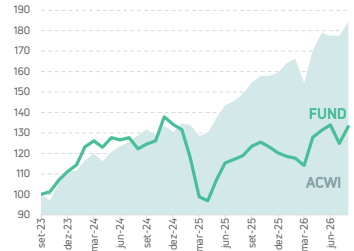


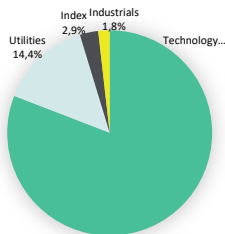
INVESTMENT STRATEGY

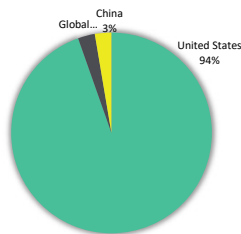
